



### **Release of Liability, Waiver of Claims & Assumption of Risk Agreement**

*Please read carefully. Ticking the box during sign-up constitutes your agreement.*

To participate in any activities provided by **Ocean Warriors SLSC**, it is essential that you understand and acknowledge the inherent risks involved and accept full responsibility for your child's informed and voluntary participation.

Ocean Warriors SLSC has implemented comprehensive safety procedures to promote a secure environment; however, the nature of these activities means that a certain level of risk cannot be entirely eliminated. By allowing my child to participate, I acknowledge that they may be exposed to a range of risks and hazards, both known and unknown. I understand the scope of the activities, services, and equipment provided by Ocean Warriors SLSC and accept that participation may result in physical injury, or in rare cases, serious harm or death.

I recognise that these activities can be physically demanding and may require a certain level of fitness and skill. I understand that it is my sole responsibility to assess my child's ability to safely participate and I voluntarily assume all risks associated with their participation. I accept full responsibility for any injuries, losses, or damages that may occur as a result of my child's involvement.

I further acknowledge that misuse of equipment or failure—whether intentional or unintentional—to follow instructions, safety procedures, or club rules may result in full liability being assumed by the participant.

### **Use of Images**

I grant permission for Ocean Warriors SLSC to use photographs and/or video footage of my child for promotional purposes, including but not limited to social media, advertising, and publications. Ocean Warriors SLSC commits to respecting local cultural and community sensitivities in the use of such media.

### **Waiver and Release**

To the fullest extent permitted by law, I hereby waive, release, and discharge Ocean Warriors SLSC from any and all claims, liabilities, demands, or actions—whether now known or unknown—including those arising from negligence (excluding gross negligence), for any loss, damage, illness, emotional distress, injury, or death sustained by myself or my child as a result of participating in activities or using any equipment and facilities provided by Ocean Warriors SLSC.

### **Medical Declaration**

I acknowledge that it is advisable to consult with a medical professional before engaging in any physical activity. I confirm that I have either done so or have chosen not to consult a physician at this time. I affirm that my child does not suffer from any medical condition that may impair their ability to safely participate in the activities offered by Ocean Warriors SLSC. This includes, but is not limited to: heart conditions, epilepsy, severe allergies, skeletal or spinal conditions, or a history of sports-related injuries. I understand that participation despite such conditions could place my child and others at risk.

**Parent/Guardian Declaration**

As the legal guardian of the minor named in this agreement, I accept full responsibility for my child. I understand that Ocean Warriors SLSC's duty of care concludes once my child leaves the premises. I hereby agree to all of the terms outlined above and further agree to indemnify and hold harmless Ocean Warriors SLSC from any claims or legal actions brought by, or on behalf of, my child.
